Interment Rights

The following prices includes the interment rights, care & maintenance fund contribution, and HST.

Preferred Single Grave Flat Granite Marker Lot	\$1921.00
2-Grave Monument Lot	\$4463.50
2-Grave Shared Monument Lot*	\$9373.35

*A shared monument lot is a lot with a pre-installed monument shared with the lot behind it. Ownership of the shared monument is retained by the Cemetery. The Cemetery reserves the right to perform all inscription work on shared monuments. In addition to the cost of the lot, the above price includes the following:

Inscription Rights to Monument and First Inscription	\$4000.00
Monument Foundation	\$245.00
Care and Maintenance Fund Contribution	\$100.00

Each individual grave may accommodate a maximum of three interments in one of the following combinations: 2 caskets and 1 cremation urn (provided the first casket is buried at extra depth), 1 casket and 2 cremation urns, 3 cremation urns. Please refer to the cemetery by-laws for memorialization restrictions.

Care and Maintenance Fund Contribution

Graves 24 square feet or larger (adult grave):	The greater of 40% of the lot price and \$290.00
Graves less than 24 square feet (child/cremation grave):	The greater of 40% of the lot price and \$175.00

Interment Fees

The following prices include digging and backfilling the grave, removal of excess soil, reseeding and fertilizing. HST is not applicable to these prices.

Interments must be in the cemetery by 3:00 on weekdays.

Interment services will be limited to 30 minutes from the scheduled arrival time.

Arrival more than 30 minutes from the scheduled service time, or failure to vacate burial area after the allotted service time: \$250.00 per half hour.

Additional Saturday Service Notes

Funeral Mass or Chapel Service times after 10:30 will not be accepted. Funerals must arrive in the cemetery by 12:00. Graveside cremation services not preceded by a Funeral Mass or Chapel Service will be limited to 3 per Saturday, and must be scheduled for one of the following times: 9:00, 9:45, or 10:30.

Payment Terms

For all at-need purchases, payment is due in full.

Pre-need purchases under \$5000.00: 40% deposit due at time of purchase, with balance payable quarterly for 1 year, interest free.

Pre-need purchases over \$5000.00: 40% deposit due at time of purchase, with balance payable quarterly for 2 years, interest free.

Pre-need services purchased separately from interment rights are due in full at time of purchase.
