## \*Care and Maintenance Fund Contributions

As required under the *Funeral, Burial and Cremation Services Act, 2022* and Ontario Regulation 30/11, the amounts below will be contributed to an irrevocable trust fund known as the Care and Maintenance Fund. Income (interest) from this fund is used to cover care and maintenance expenses of the cemetery in perpetuity.

Graves 24 square feet or larger (adult grave):	The greater of 40% of the lot price and \$290.00
Graves less than 24 square feet (child/cremation grave):	The greater of 40% of the lot price and \$175.00
Columbarium Niche:	The greater of 15% of the niche price and \$165.00

## Late Arrival Fees, Saturday Fees

**Interments must be in the cemetery by 3:00 on weekdays, and 12:00 on Saturdays. Funeral Mass or Chapel Services times after 10:30 on Saturday will not be accepted. Graveside cremation services not preceded by a Funeral Mass or Chapel Service will be limited to 3 per Saturday, and must be scheduled for one of the following times: 9:00, 9:45, or 10:30. All interment services will be limited to 30 minutes from the scheduled arrival time.**

## Cremation Services (Holy Cross Catholic Cremation Centre, Paris)

Cremated remains will be presented in a plastic/cardboard container that is suitable for interment. The price of cremation below includes this container, as well as the Bereavement Authority of Ontario Consumer Protection Fee. HST is not applicable. Our typical turnaround time is 3 to 5 business days. Expedited cremation (under 48 hours from time of transfer and with all necessary documentation received) is available for an additional fee.

You are not required to purchase an urn or an urn vault (for-in-ground burial). When a body is cremated, the cremated remains will be presented in a box that is suitable for interment as is. Nonetheless, we are pleased to offer a variety of products in a range of prices and materials to suit your preferences. If the urn is to be placed in a columbarium niche at the cemetery, you must make sure the urn you select will fit. Please speak with one of our staff members for assistance.

## Care and Maintenance Fund Contribution

As required under the *Funeral, Burial and Cremation Services Act*, 2002, the following amounts must be paid to the cemetery operator before a marker is installed. After each marker installation, the amount will be contributed to an irrevocable trust fund known as the Care and Maintenance Fund. Interest from the fund will be used to cover expenses for the care and maintenance of markers and monuments in perpetuity.

## Payment Terms

### For services at time of death

For all at-need purchases, payment is due in full. Financial assistance for burial and cremation services is available through various governmental agencies, to those who qualify.

### Pre-payment in advance of need

For services and supplies that are being arranged pre-need, you may pay for the services and supplies at today's price and we will place your money in a trust fund where it will accrue interest until the pre-paid contract is fulfilled (when the supplies and services are delivered). Funds are held in the purchaser's name.

### For In-Ground Interment Rights Purchases

Pre-need purchases under \$5000.00: 40% deposit due at time of purchase, with balance payable quarterly for 1 year, interest free.

Pre-need purchases over \$5000.00: 40% deposit due at time of purchase, with balance payable quarterly for 2 years, interest free.

Pre-need services purchased separately from interment rights are due in full at time of purchase.

### For Cremation Niche Interment Rights Purchases

Pre-need purchases under \$5000.00: 25% deposit due at time of purchase, with balance payable quarterly for 1 year, interest free.

Pre-need purchases over \$5000.00: 25% deposit due at time of purchase, with balance payable quarterly for 2 years, interest free.

Pre-need services purchased separately from interment rights are due in full at time of purchase.

## Guarantee

When paid in full in accordance with the payment terms set out in the prepaid contract, the prepaid contract is guaranteed. The total payment(s) plus any interest/growth earned will be applied to the future price of the services and supplies. If the total payments plus interest/growth earned are insufficient to cover the total future price of the prepaid services and supplies, we will absorb the difference as a loss. Any funds in excess of the total future price of the prepaid services will be returned. Any changes to the prepaid contract may result in the prepaid contract being null and void and a new contract being executed with current pricing at the time changes are made.

### For memorialization services

A 50% deposit is due at the time of purchase, with the balance payable upon completion of the order.
